## **NOTIFICATION**

Whereas the Government of India have enacted the Real Estate (Regulation and Development) Act, 2016 (hereinafter referred to as the 'Act') with effect from 26.03.2016;

Whereas the Government of Karnataka have notified the Karnataka Real Estate (Regulation and Development) Rules, 2017 (hereinafter referred to as the 'Rules') in the Karnataka Gazette on 11.07.2017;

Whereas the Government of Karnataka, vide Notification No. DOH 158 KHB 2017, dated 16.12.2017, had designated the "Karnataka Appellate Tribunal" as the "Karnataka Interim Real Estate Appellate Tribunal" under Section 43(4) of the said Act read with Rule 31(9) of the said Rules;

Whereas the Government of Karnataka, vide Government Order No. DOH 4 RERA 2017, dated 22.05.2018, have given approval for opening the "Karnataka Real Estate Regulatory Fund";

Whereas the Government of Karnataka, vide Notification No. DOH 24 RERA 2017, dated 08.03.2019, have appointed Justice Shri B. Sreenivase Gowda, Former Judge of the High Court of Karnataka as the Chairperson of the Karnataka Real Estate Tribunal; and the said Chairperson has assumed charge on 13.03.2019;

Whereas the Government of Karnataka, vide Notification No. DOH 24 RERA 2017, dated 05.03.2019, have appointed Shri Dinesh K.P., as Judicial

Member of the Karnataka Real Estate Appellate Tribunal; and the said Member has assumed charge on 09.05.2019;

Whereas the Government of Karnataka, vide Notification No. DOH 24 RERA 2017, dated 05.03.2019, have appointed Shri Somashekar. P.S., as Administrative Member of the Karnataka Real Estate Appellate Tribunal; and the said Member has assumed charge on 08.03.2019;

Now, in exercise of the powers conferred by sub-section (1) of the Section 43 of the Real Estate (Regulation and Development) Act, 2016, the Government of Karnataka hereby establishes for the State of Karnataka, the Tribunal to be known as "The Karnataka Real Estate Appellate Tribunal" which shall have its headquarters at Bengaluru. "The Karnataka Real Estate Appellate Tribunal" is deemed to have come into existence with effect from 13.03.2019, the day which the Chairperson of the said Authority has assumed the charge. The said Tribunal shall function with effect from 03.01.2020.

"The Karnataka Real Estate Appellate Tribunal" shall function at the following address:-

In terms of second proviso to sub-section (4) of the Section 43 of the said Act, all matters pending with the Karnataka Interim Real Estate Appellate Tribunal (Karnataka Appellate Tribunal), stands transferred to the Karnataka Real Estate Appellate Tribunal, with immediate effect and shall be heard from the stage such appeal is transferred.

The salaries and allowances payable to the Chairperson and Members including the officers and other employees, and the administrative expenses

of the Karnataka Real Estate Appellate Tribunal, shall be met out of the 'Karnataka Real Estate Regulatory Fund' as provided under Section 75 (2) (a) of the Real Estate (Regulation and Development) Act, 2016.
