


This document contains step by step instructions to fill the application form for Extension of the Project Registration / Completion of Project Registration

Step 1: To apply for Extension of Project Registration visit the RERA Portal click on the Registration Tab and below again click on the Apply for Extension / Completion.




Step 2: The login screen will appear for logging in considering RERA Registration number as key factor. And for reference user can download



- Certificate format by clicking on respective link.




Step 3: Enter RERA Registration number and enter the OTP sent to the user E-mail and Mobile number and click on Login



Step 4: After Logging in, read the Important points.



B. To Apply For Extension Click on Apply for Extension Button and Fill The Form.






Step 6: After all the above details and submitting by clicking Next, the Extension payment form will open with promoter name and Amount will be auto-filled. And click on "click here for Online payment".
